

Terms & Conditions for abstract submissions

1. I certify that the authors/presenters named agree with the submitted abstract and have consented to be included.
2. I certify that I have checked the accuracy of information and referencing
3. The submitted abstract need to be current and not published elsewhere already! Published abstracts will not be considered.
4. If my abstract involves a sponsoring company, I have indicated this in the body of my abstract
5. If my abstract involves a sponsoring company, I have no financial conflict (i.e. I have no shares in the sponsoring company)
6. If my abstract involves a sponsoring company, and I have received funding from the sponsoring company in the last five years, I have declared this in the abstract and the Funding Disclosure section
7. Medineo is charging an administration fee for every submission. The administration fee has to be paid via the online payment system. Select "Submission fee for conference..." in the booking area of the conference and proceed with the payment. Submissions that are not paid before the deadline are not reviewed by the Scientific committee.
8. When the Scientific committee has completed the review process, all submitting authors will be notified in writing of the acceptance or otherwise of their abstract(s). I accept that the committee decision is final and agree that no correspondence will be entered into
9. It is a condition of abstract acceptance that the presenting author will register for and attend the conference. Poster presenters and those doing workshop will be expected to be assisted by a colleague who must also register for the conference. Presenters and colleagues selected receive a discount of 15% on the delegate fee.
10. I accept that all accepted abstracts may be published in the Conference programme book.

3. Pay the administration fee via our online payment system.
4. Wait for our feedback.
